1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within $L-1+ 15\%$ of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Bidder/ contractor should have registered office in Himachal Pradesh. Attach valid proof.
2. The agency should have obtained license from the Controlling Authority of Himachal Pradesh under section 7(5) of the "The Private Security Agencies (R

egulation) Act 2005". Attach the Proof.

3. The Office of ICAR-DMR, Solan may at its discretion at any point of time during the validity of contract, require the service provider to dismiss or remove from the site of work, any person or persons employed by the service provider. The service provider shall forthwith comply with such requirements.
4. Please submit the acceptance of buyer added ATC duly signed and stamped on letterhead of the firm and fill the Questionnaire and qualifying criteria requirement attached herewith(on last page of buyer uploaded ATC document).
5. Pre-bid meeting for inspection of premises by bidding firms is scheduled to be held at DMR on 27.11.2025. Participation in the meeting is compulsory and only firms attending pre-bid interaction will be considered for technical evaluation.
6. The agency shall give weekly off on seventh day as per rules. The agency shall provide additional security guard as reliever to perform the duties in shift in weekly off days.
7. In the event that two or more bidders submit their technical or financial bids using the same IP address, or if the IP address of any bidder matches the IP address used for tender creation, the system (GeM) will automatically flag such instances as potential indicators of collusion or bid rigging. Any bidder involved in such a case, shall be summarily disqualified from the tender process without further consideration/ clarification.
8. Due to any technical/financial difficulties if the institute is not able to pay the contractor payment on time, contractor should be able to pay the workers at least 3 month wages on his own. There should not be any linkage between payment to their workers and the release of bill amount from the Institute (ICAR-DMR).
9. A contractor shall not charge or collect any fee for engaging or employing workers for their deployment. Any such activity will amount to violation of the terms of the contract and the principal employer will be free to take appropriate action against the contractor as per applicable laws, rules and policies in this regard which may include termination of the contract, blacklisting of the contractor, etc.
10. The agency shall, at its own cost, provide suitable uniforms with shoes to the personnel with identity cards. Logo and name of the firm should be clearly embroidered on uniform. The contractor will provide the uniforms, whistle, torch, lathi, umbrella, raincoat, etc. to the guards required for performance of duty. This cost incurred for uniform and other accessories should be borne by the Security Agency.
11. The firms should also upload GST certificate, PAN, EPF, ESI, MSME certificate.
12. No separate payment will be made for supervisors deployed by the contractor. The contractor has to bear the payment of the supervisor.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
